The Town Attorney, John DiCaro verified that the Legal Notice was properly published as required by law.

Supervisor Giunta asked if the applicant was present to speak on this?

Present were, Abdul Reza Samadi, president of the Lazeez Kabob House as well as general manager and Aimal Sultan who is the co-buyer and the general manager of the Kabob House which is located at 1273 Chili Ave. The plan is to open a dine-in and take-out Afghanistan & Pakistani food restaurant.

Mr. Sultan replied about sixteen (16). He shared a letter of intent as well.

Supervisor Giunta asked if they owned restaurants previously?

Mr. Sultan replied he was previously worked is several restaurants and is currently a real estate agent, but has had several other businesses including car sales as well as a restaurant in Afghanistan.

Supervisor Giunta asked if approved, what would the hours of operation be and how many employees?

Mr. Sultan replied, Sunday to Thursday from 6:00am to 10:00pm and Friday & Saturday from 7:00am to 11:00pm. The hotel has asked them to provide breakfast for the guests. He added, right now he has 10-12 employees on the schedule, but looking for more people.

Supervisor Giunta asked of they will serve alcohol?

Mr. Sultan replied, No alcohol. He presented a copy of the site-plan and passed it to the board.

Supervisor Giunta reminded Mr. Sultan to visit the Building Department, the Fire Marshal and Building Inspectors with the site-plans for approvals with any type of construction, lighting, and sign permits needed prior to moving forward.

Councilman Tucciarello asked why there are different plans (A1, A2, A3....)?

Mr. Sultan believes there were some plans from the prior business idea, but his is Site Plan A3

Councilman DiPonzio asked about the entrance?

Mr. Sultan, there are two (2) entrances from the main lobby. One for hotel guest and other for anyone else but both through main lobby.

Mr. Kallstrand, yes, beer, wine, and liquor. They already have their temporary license and are hoping to open next week sometime. They currently have 20 employees and hope to hire more.

Supervisor Giunta added to be sure to visit the Building Department and get all the permits required for any and all construction changes.

Mr. Kallstrand replied, building inspector Mr. Minster has already been there and approved all the updates.

Councilman Tucciarello added their reputation in the Brockport location is very good and has friends who visited many times and really enjoyed it. It's good to see a business come in with such great experience and take over this building, which is in the center of the town. He is very happy with this.
